### CALL TO ORDER

Chair Schmider called the meeting of the Executive Committee of the Interstate Commission for EMS Personnel Practice to order at 3:00 p.m. Friday, August 6, 2021, and took roll call.

## NREMT

Tilton updated the committee NEMSCD

- Kansas will have most, if not all, of their information in today
- Louisiana is in the QA process
- Texas using the database frequently to determine who the states have licenses to practice in another state
- Colorado happy to have another bordering state with data in the system

Moller shared that work continues on the new website for the EMS Compact. Woodyard recognized the National Registry for their continued support s to supply staff and resources to assist with the website development. Woodyard then asked other commissioners and stakeholders to offer their input on what they would like to see on the website.

## Educator

Manz sadly announced the passing of Drexdal R. Pratt, Director of the NC Division of Health Service Regulation (retired)

Manz updated the committee on the following:

- Dr. Lynthia Andrews Bowman, Chair Missouri EMS Advisory Council, responded in writing (attached herein) that the User Access Agreement is an important step forward and addresses many of their concerns regarding security of data within NEMSCD

*House motioned to accept Dr. Bowman's letter into the minutes; Woodyard seconded. With no discussion the motion was approved without dissent.*

- Presented to the Federation of Associations of Regulatory Boards (FARB) on how the EMS Compact works and an overall perspective on compacts in general during their virtual Leadership Conference.
  - Session: Issues with Licensure Portability and Interstate Movement of Personnel
  - Great interaction
  - 50-60 in attendance
- Legislation
  - Several states have legislation pending, picking up a state or two month that are in the process of having legislation introduced, the common thread that is surfacing is the Department of Defense (DoD)
  - The DoD is a big supporter of health profession licensure compacts, as they make mobility easier for significant others to move with the service member, especially when they are a paramedic, nurse, or physical therapist
  - The DoD has now begun approaching legislators in a target state who understand compacts, understand licensure portability and mobility, and are willing to support health professions. The DoD will ask them to introduce all the compacts in in one fell swoop
  - Manz will send a letter to the legislator involved and copy the State EMS office thanking them and introducing himself and offer to answer questions
  - Manz recently received a reply from one of the State EMS Official stating they do not support compact because
    - The cost of participating is undefined and ambiguous
    - The background check requirements are not as rigorous, and it would be a step backwards in terms of public protection
    - There is no standard disciplinary process among the States, and the feel this sets up some disparities in terms of how this thing would be administered
    - Their state does not license anyone for a health profession with a felony background of any kind and they feel some other compact member states may and they would not welcome someone who had a felony background to operate in their state
    - Very specific outlooks on why the state wasn't planning on participating
    - Would like to reach out to them and inform them of the benefits of the compact
    - Chair Schmider ask Manz to reach via a phone call
  - Wolfberg informed the Executive Committee the director of the state department of military affairs from the above-mentioned area reached out to Rick Masters, counsel for the Council on State Governments, requesting he set up a meeting with the counsel for the EMS Compact to discuss the concerns of the State EMS office. Wolfberg is happy to participate with Chair Schmider's permission. Chair Schmider asked Wolfberg to participate in the meeting.
- NASEMSO
  - Manz recommended hosting non-member states and conducting a COMPACT 101 session

- Chair Schmider likes the idea
- Vice-Chair Woodyard believes it would be a venue to share how other states handle the fitness to practice concerns within their states

## OTHER BUSINESS

### Rules Amendment Update

- Rule amendments were posted to the EMS Compact website for a 60-day review period
- Rule amendments will be voted on September 16, 2021, at the Commission meeting
- To date there have been no public comments
- Need to encourage member states to review the language, as the changes are based on stakeholder feedback
- Manz will draft communication and send out informing member states to review the new language, as they will be held accountable and need to understand the update prior to the September 16 meeting.

The Missouri EMS Compact Sub-committee, which is part of the State EMS Advisory Council, met last week and discussed the various items you provided to us regarding database privacy and possible sale of data from the database.

The consensus of the committee is that the national compact "User Access Agreement" regarding database privacy which is attached to the National Registry policies is a very important step forward. This answers many of the concerns we have expressed about the security of the data and we support the Compact Board of Directors with these steps.

We also reviewed and discussed the revised agreement between the Compact and the National Registry. We think that the changes clarify the questions that were raised about the possible sale of data.
